1. Introduction

The Information and Privacy Commission NSW (IPC) is an independent statutory authority that administers legislation dealing with privacy and access to government held information in New South Wales (NSW). It promotes and protects privacy and information access rights in NSW and provides information, advice, assistance and training for agencies and individuals on privacy and access matters.

The IPC administers the following legislation:

- [Government Information \(Information Commissioner\) Act 2009](#) (GIIC Act)
- [Privacy and Personal Information Protection Act 1998](#) (PPIP Act)

2. Key information access resources for public sector agencies

This compendium identifies the key guidance provided by the IPC to ensure that agencies are able to meet their fundamental requirements under the GIPA Act. The guidance has been arranged on a functional basis that reflects agency, senior executive and decision-maker responsibilities.

The IPC's training and education are delivered via a variety of methods to assist you to perform your duties as a public sector agency officer under the legislation. GIPA compliance reports	The IPC is focusing its audit activity on providing insights into key areas of compliance which pose risk and impact accountability, transparency, open access, and the right to access information by citizens. Through its published audits, the IPC aims to provide the entities we regulate with broader insights that inform and challenge government to improve transparency and accountability and improve outcomes for citizens.
