Research Design

- The Information and Privacy Commission omnibus interviews were conducted with 340 adults aged 18 years and over in New South Wales.
- Interviews were conducted using both online interviews and in-house CATI (computer assisted telephone interviewing).
- Following the completion of interviewing, the data was weighted by age, gender and areas to reflect the latest ABS population estimates.
- Results that are statically significant are shown in bold GREEN or RED when higher or lower respectively.



Research Design

- Fieldwork was conducted between 28th of February to the 3rd of March.





Knowledge of Right to Access Personal Information Public Health Service Providers












4. Have you ever considered accessing any personal information held about you by any of the following agencies?

Incidence of Attempting to Access Personal Information Amongst those who Considered




5. Have you ever tried to access personal information held about you by any of the following agencies?


Accessed Personal Information Successfully
